## All Terrain and Utility Terrain Vehicle Club Route Maintenance Agreement Agreement No. 17-19-03

This Agreement made between the Town of Pleasant Valley, Eau Claire County (hereinafter referred to as the Town) and “Big Creek ATV/UTV Club” (hereinafter referred to as the Club).

**WHEREAS**, on May 8, 2017 the Town Board of the Town of Pleasant Valley adopted Ordinance No. 17-15-02 “All-Terrain Vehicle/Utility Terrain Vehicle Routes And Regulation Of All-Terrain Vehicle Operations” authorizing the designation of approved town roads as ATV/UTV Routes, and

**WHEREAS**, the Town of Pleasant Valley Town Board has authority to enter into an agreement appointing an ATV/UTV Club to manage all aspects of said ordinance and subsequent resolutions, and

**WHEREAS**, the Club shall be responsible for the following:

1. Review and accept any route application made to the Town requesting a town road be designated as an ATV/UTV route.
2. Present any Club approved application to the Town Board.
3. Purchase of and other associated costs related to the necessary signage of approved routes.
4. Installing and maintaining the proper signage of all routes approved by the Town.
5. Annually provide a list to the Town Board the names and contact information of all Club officers.
6. Annually provide an appointed contact person for the Club.
7. Maintain a current inventory of all ATV/UTV signs located in the Town which includes the sign type, post type, location and installation date of each sign. This current inventory shall be provided to the Town Clerk anytime a sign is added, replaced or removed.

**WHEREAS**, The Town shall be responsible for the following:

1. Review and consider for approval by resolution any applications received in accordance to Ordinance No. 17-15-02 at the next regularly scheduled Town Board meeting.
2. Approve all signage, signage materials and locations of signs.
3. Maintain a current list of approved routes on the Town website ([www.townofpleasantvalley.com](http://www.townofpleasantvalley.com)) and a posted list at the Town Hall.

**THEREFORE**, the Town of Pleasant Valley Town Board does hereby enter into Agreement No. 17-19-03 with Big Creek ATV/UTV Club as the designated Club to manage approved ATV/UTV Routes within the Town of Pleasant Valley

**BE IT FURTHER RESOLVED**, the term of this agreement shall be indefinite. Either party may terminate this agreement without cause upon thirty (30) days written notice to the other party, and, If said Club dissolves, this agreement shall be considered null and void, and such termination will close all designated routes on Town roads and all signage shall become the property of the Town.

**BE IT FURTHER RESOLVED**, no compensation is implied for said appointment.
